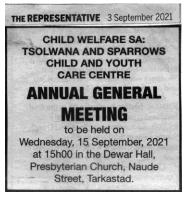

Sparrows: 21 Years in Review

The Sparrows idea started in 1996. God asked me to look after His misplaced people: house, clothe and feed them.

I was given three instructions by Dr Tony Campolo (American sociologist, pastor and author):

- 1. Get the blessing of your family
- 2. Pray for God to show you someone who shares your vision
- 3. Have strict timelines

I fulfilled the first two within two months. Then the fun began.

We purchased three houses and a vacant plot. The boundaries connected and we had a large area to work with.

Money came from friends and donors. I must tell you about my partner – my Siamese twin from another mother. We were joined at the hip.

Jean is blonde and beautiful. She was the charmer. I would send her in ahead. After she had charmed and convinced the donor to part with their money, I would come in for the kill. It sounds very calculating, but it worked. Jean kept me excited and I kept her grounded. A winning combination. Sadly, she later emigrated to the United States.

We welcomed our first eleven children on 13 April 2000. They arrived in an Opel. Jean rushed them off to play a game. I disappeared into the house to have a good cry. The moment was too great – the responsibility was overwhelming.

Phelisa Phaliso arrived on that day and is now a social worker. We are very proud of her achievements. All four of our matriculants over the years were prefects at Tarkastad High School. I do believe that education is the best inheritance we can give our children. Koos Tamboer went to Merryvale School for children with special needs. He was the head prefect of his school and was offered a position on the staff. He still works there.

We later bought an adjacent house to the plot and renovated it to become the foster home. We inherited Kabouterland Educare Centre from Child Welfare Queenstown.

The vacant plot is currently used by the community as a vegetable garden.

At present, we have 22 children, a manager, a social worker, six child care workers and a social auxiliary worker.

The success of Sparrows was not due to two people. Many contributed, especially our families. I would like to pay tribute to the late PJ Budler, Jean's husband, and BJ van Heerden, mine, as well as our children.

The mere fact that you support us today means so much to all of us in the organisation. You, the community, have carried us through the times when we had to stay behind locked doors. It was not always easy as the children sometimes became restless. The staff also had to be very conscious not to bring Covid 19 into Sparrows.

I am so proud of the children and staff for embracing the unusual situation and making the best of it. In the beginning, we were in total lockdown. It was fun in the beginning, but as time went on, we realized that COVID 19 was here to stay for a while. We drew closer as a family and had time to reflect on how we were doing things and how to move forward in this unnatural time.

The children were able to go home for the Christmas holidays. I would like to thank the external social workers for organising the holiday placements as well as the families who hosted the children. It is a financial strain on families to accommodate more children into their homes over the festive season. We do assist by sending food parcels as well as new clothes and gifts for our children.

We have been reporting about one of our boys who was hard of hearing when he arrived at Sparrows. After two operations to repair his eardrums, he can hear properly. He has been officially discharged from medical care. We are very grateful to the Ear, Nose and Throat Department at the Frere Hospital.

We have a girl in matric this year! She is also a prefect at Tarkastad High School. We are so proud of her. She will be studying further next year. We wish her well in her endeavours.

The staff must be commended for their dedication and commitment. This past year has been no different to others as far as payment of subsidies is concerned. The quarterly payments were seldom on time, but the staff endured and continued working.

This has been a very difficult year for education. WhatsApp teaching became the norm as teachers sent messages to and fro. Sparrows was a flurry each morning as children and staff settled into classroom mode. I would like to thank Faith, the social worker, and Monica, the social auxiliary worker, for assisting the childcare workers each day. I would also like to thank the educators for trying their best.

Fundraising became very difficult as we were not able to host our annual fundraising events. This did not deter Rachel. She found innovative ways to continue raising awareness and funds. We appreciate her dedication to the organisation as a volunteer.

David has been a gem. He has assisted me with issues where I was out of my depth. Thank you, I appreciate you.

Case Work

- 5 children from the foster home were admitted to Sparrows
- Assessment for holidays were done by the internal social worker, external social workers and the manager
- Counselling and therapeutic sessions are done regularly with the children by the internal social worker
- External social workers and other professionals have been invited on different occasions to assist with counselling sessions and to attend family conferences
- Individual development plans are done by multi-disciplinary teams and the relevant child. The child's growth and development is encouraged and monitored. This is reviewed every 6 months.

Group Work

- The children are grouped according to their ages. The groups are working well on Fridays and during holidays. It is helpful toward the children's behaviour as they formulated the group rules and the consequences for not adhering to the rules.
- Sessions were facilitated with the children on topics such as:
 - o Life skills
 - Independent living for children disengaging from the residential care programme
 - Victim empowerment
 - Family preservation
 - Promotion of the rights of children
 - Income-generating activities
 - o Individual counselling
 - Grief counselling
 - Trauma counselling
 - Play therapy
 - Psycho-social support

Successes

- A child with a hearing problem had successful operations. His last check-up was on 5 August 2021.
- Our Grade 12 learner at Tarkastad High School was elected as a prefect.
- Therapeutic group work has resulted in children being able to voice their feelings more easily.

- A mother of one of the children placed at Sparrows was able to change her lifestyle and successfully take care of her and her sister's child during the holidays. She was encouraged to continue what she is doing to take care of her child.
- The Journey of Life programme helped most of our children to reflect on who they are and why they were placed at Sparrows. Children were grouped by age and most participated.
- Programmes aimed at older girls were successful according to participation and feedback after every session.

Challenges

- We were not allowing visitors at Sparrows during higher lockdown levels. The children found it difficult not to see their parents for family conferences.
- Some parents did not comply with instructions to return their children on a specific date after the holidays, instead hiding them. The external social worker located the children with the assistance of SAPS.
- Some children returned from holidays with sores, broken arms, stab wounds and dirty clothing.
- Teasing and bullying is a challenge at Sparrows, especially targeting children with low selfesteem.
- Some children have difficulty with controlling anger. It is difficult to find the causes.
- Some children avoid being vulnerable by avoiding discussions about deeper issues.
- Sharing of clothes among the older girls is a challenge.
- One parent presented a challenge by not adhering to rules and policies implemented at Sparrows, particularly in relation to preventing Covid 19.

Social Auxiliary Worker's Report

Psalm 139:1-2 – "You have searched me, Lord, and you know me. You know when I sit and when I rise; you perceive my thoughts from afar."

I did not join Sparrows for fun. You made me a pillar of strength for Your purpose. This is how You showed Your love, mercy and kindness to the community of Tarkastad.

Positive Outcomes: 1 April 2020 – 31 March 2021

- 500 community members were reached through food and vegetable donations during lockdown
- Two orphaned children were placed in foster care within their families
- Three rape cases were opened and successfully prosecuted
- Eight clients who did not manage in mainstream schools were referred to the occupational therapist for further assistance
- Five neglected children were removed from their maternal families and placed with their paternal families
- During 16 Days of Activism, a men's empowerment campaign ("Not In My Name") proved successful and resulted in some men opening up about abuse they suffer from women.
- The "Back to School" campaign was successful. Children needing school uniforms were referred to the Department of Social Development for assistance.

Priority Challenges

- Unemployment: Our communities are the poorest of the poor. Because of illiteracy and other circumstances, privileges and benefits are received by the people who are familiar with those in authority. This makes it difficult for people to find employment. Substance abuse in the workplace also plays a role.
- Substance Abuse: This is becoming more of a challenge, especially with young children becoming involved. This has led to an increase in the crime rate, especially assault, theft, robbery, burglary and break-ins.
- Gender-Based and Domestic Violence: Children are exposed to this on a daily basis in the community, leading to serious behaviour challenges.
- Teenage Pregnancy: Due to the above challenges, many teenagers leave school and cohabit with men to alleviate their situation. This often leads to unplanned pregnancies.

Majority of the year, the Educare Centre was closed, but the staff continued in their faithfulness to the children and the heart behind educating them.

Competitions

The restrictions on face-to-face events got us thinking out of the box. A raffle event each month became staple. From chocolate cake to biltong cake to hampers, this provided an unexpected income which would normally receive from food sales.

Our annual Christmas in July event initiated a food take-away for the evening.

Hunt Auction

While this event was held online, the hunt packages were well-supported raising almost R50'000. AuctionOne with Justin Rothbart offered us assistance with advertisinig and logistics of an online auction. We really appreciate their continued support.

Live in the Garden

In October, we were able to do a small event through the Victory Family Church and The Shed in Cradock. Kim Liebenberg provided live music with the help of Aiden. The Shed, other businesses and Unitas International provided food for the event. Our profit was over R12'000 for this special evening. Plans are underway for this to become an annual event.

NPO Fundraising Forum

In September, I began attending the NPO Fundraising Forum through Sparrows' Patron, Annelise de Jager. New insights have been gleaned which I hope to begin implementing at the end of the training period.

Christmas Shoeboxes

Victory Family Church took the initiative to prepare a Christmas shoebox for each child at Sparrows. We are grateful for their and kindness and continuous care for our children.

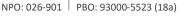

ACCOUNTING POLICIES

1. General information

Child Welfare SA - Tsolwana & Sparrows Child & Youth Care ('the Non-Profit Organisation') is a shelter for less and underprivileged children.

2. Basis of preparation and summary of significant accounting policies

The financial statements of Child Welfare SA - Tsolwana & Sparrows Child & Youth Care have been prepared in accordance with the basis of accounting set out below and the Non-Profit Organisations Act of South Africa. The financial statements have been prepared under the historical cost convention. They are presented in South African Rand.

The principal accounting policies applied in the preparation of these annual financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

2.1 Property, plant and equipment

Property, plant and equipment is stated at historical cost less accumulated depreciation and any accumulated impairment losses. Historical cost includes expenditure that is directly attributable to bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by the board members.

The Non-Profit Organisation adds to the carrying amount of an item of property, plant and equipment the cost of replacing parts of such an item when that cost is incurred if the replacement part is expected to provide incremental future benefits to the Non-Profit Organisation. The carrying amount of the replaced part is derecognised. All other repairs and maintenance are charged to surplus or deficit during the period in which they are incurred.

Land is not depreciated. Depreciation on other assets is charged so as to allocate the cost of assets less their residual value over their estimated useful lives, using the straight-line method. The estimated useful lives range as follows:

4 years
6 years
3 years

2.2 Financial instruments

Loan to group entity

This can include loans between holding entities, fellow subsidiaries, subsidiaries, joint ventures and associates and are recognised initially at fair value plus direct transaction costs.

The loan to group entity is classified as a financial asset at amortised cost, and is initially measured at fair value plus transactions costs and subsequently measured at amortised cost using the effective interest rate method.

Trade and other receivables

Trade and other receivables are recognised initially at the transaction price. They are subsequently measured at amortised cost using the effective interest rate method, less provision for impairment. A provision for impairment of trade receivables is established when there is objective evidence that the Non-Profit Organisation will not be able to collect all amounts due according to the original terms of the receivables.

Qualified Opinion

ACCOUNTING POLICIES

1. General information

Kabouterland Educare Centre ('the Non-Profit Organisation') is a pre-primary play school.

2. Basis of preparation and summary of significant accounting policies

The financial statements of Kabouterland Educare Centre have been prepared in accordance with the basis of accounting set out below and the Non-Profit Organisations Act of South Africa. The financial statements have been prepared under the historical cost convention. They are presented in South African Rand.

The principal accounting policies applied in the preparation of these annual financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

2.1 Property, plant and equipment

Property, plant and equipment is stated at historical cost less accumulated depreciation and any accumulated impairment losses. Historical cost includes expenditure that is directly attributable to bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by the board members.

The Non-Profit Organisation adds to the carrying amount of an item of property, plant and equipment the cost of replacing parts of such an item when that cost is incurred if the replacement part is expected to provide incremental future benefits to the Non-Profit Organisation. The carrying amount of the replaced part is derecognised. All other repairs and maintenance are charged to surplus or deficit during the period in which they are incurred.

Land is not depreciated. Depreciation on other assets is charged so as to allocate the cost of assets less their residual value over their estimated useful lives, using the straight-line method. The estimated useful lives range as follows:

2.2 Financial instruments

Loan from group entity

The loan from group entity is classified as a financial liabilities at amortised cost, and is initially measured at fair value plus transactions costs and subsequently measured at amortised cost using the effective interest rate method.

Cash and cash equivalents

Cash and cash equivalents includes cash on hand, demand deposits and other short-term, highly liquid investments with original maturities of three months or less. Bank overdrafts are shown in current liabilities on the statement of financial position.

Trade and other payables

Trade and other payables are recognised initially at the transaction price and subsequently measured at amortised cost using the effective interest rate method.

2.3 Revenue

Revenue is measured at the fair value of the consideration received or receivable. Revenue is shown net of returns, rebates and discounts.
